10A. Amend Annual Salary & Compensation Rates

This Ordinance amends the salary ordinance to eliminate the position of Human Resource Mgr & amends the salary ranges for the Chief of Police & Planner.

10B. Amend GT Admin Code Chap 73 Personnel Policies

This Ordinance amends Classification of Dept Heads to include position of Twp Mgr.

10C. Amend Chap 189-4 & 189-8 Fees for Vital Statistics

This Ordinance clarifies the wording for license fees & amends vital correction fee from \$20 to \$25 per correction.

11A. Execute Agreement for Payment in lieu of Tax for Stockton College

This Resolution authorizes the agreement between GT & Richard Stockton College for property entitled to exemption for local real property taxes.

11B. Refund balance of Sewer Escrow to Ole Hansen & Sons

This Resolution authorizes the refund in the amt of \$3,979.79, as the applicant is no longer pursuing the proposed project.

11C. Emergency Temporary Appropriations in 2010 Temporary Budget

This Resolution authorizes temporary appropriation increases in the 2010 temporary budget to cover day to day operations including salaries & wages thru the beginning of June until 2010 budget is adopted.

11D. Award Bid to Infrastructure for New Leaf Crt Drainage Improvements

This Resolution awards bid in the amt of \$429,375.30 & is recommended by the PW Dir & Twp Eng.

11F. Authorizing the cancellation of outstanding checks issued by Galloway Twp Municipal Court

This Resolution authorizes the cancellation of outstanding checks issued by Galloway Township Municipal Court, that is over a year old and have never been cashed.

11G. Support Assembly Bill #1767 Enacting Jessica Lunsford Act

This Resolution supports the Assembly Bill #1767.

11H. Enter Interlocal Services Agreement w/ACUA for Solid Waste

This Resolution allows the Twp to enter agreement allowing the Twp to dispose of their waste collected to the ACUA landfill or transfer station at rates fixed for the term of the agreement.
