This Resolution objects to the adoption of the NJDEP Proposed Sewer Service Areas & Support of Changes to the NJDEP Sewer Service Areas Map.

10A. Exceed Index Rate for 2011

This Ordinance authorizes the Twp to exceed the index rate for the 2011 budget, based on the local government Cap Law.

11A. Bill Property for Cut & Clean Maintenance

This Resolution authorizes the billing where the Twp performed cut & clean maintenance, where the property was in violation of property standards.
